

Privacy Policy She does it

This is the privacy policy of She does it. Privacy-sensitive data or personal data are processed for my services. I find it important to process and secure your personal data carefully.

When processing personal data, I adhere to the requirements of General Data Protection Regulation (GDPR).

That means, among other things, that I:

- Clearly state for which purposes I process personal data via this privacy statement.
- Limit my collection of personal data to only the personal data that are needed for legitimate purposes.
- First ask for your explicit permission to process your personal data in cases where your permission is required.
- Take appropriate security measures to protect your personal data and respect your right to see, correct or delete your personal data on your request.

This statement was last amended on the 1st of January 2023.

I process these personal data:

- First and last name
- Address
- Telephone number
- E-mail address
- Other personal data that you actively provide, for example via telephone contact or email correspondence
- Information on your activities on my website.

For these reasons I process the personal data:

I have obtained the above personal data from you or from other open sources such as social media.

I only process your personal data if I am allowed to do so according to the GDPR and for these purposes:

- Sending my tips (newsletter) and / or offers.
- Preparing invoices if you have purchased a service from me.
- Being able to call or e-mail you if this is necessary to be able to provide my services.



- Analysing visitor behaviour on my website via Google Analytics.
- Complying with a legal obligation, such as the tax return.

Cookies

On my website www.shedoesitcoaching.com a cookie is placed from the American company Google, as part of the "Analytics" service.

Cookies are small text files that can be used by websites to make a user's experience more efficient.

I use cookies to personalise content and ads, to provide social media features and to analyse traffic. I also share information about your use of my website with my social media, advertising and analytics partner.

The law states that I can store cookies on your device if they are strictly necessary for the operation of this site. For all other types of cookies I need your permission. If you would like to delete or block cookies, you can do so by altering the settings in your browser. You can also at any time change or withdraw your consent from the Cookie Declaration on my website.

My website uses different types of cookies. Some cookies are placed by third party services that appear on my pages.

Necessary

Necessary cookies help make a website usable by enabling basic functions like page navigation and access to secure areas of the website. The website cannot function properly without these cookies.

Preference

Preference cookies enable a website to remember information that changes the way the website behaves or looks, like your preferred language.

Analytics

Statistic cookies help website owners to understand how visitors interact with websites by collecting and reporting information anonymously.

Marketing

Marketing cookies are used to track visitors across websites. The intention is to display ads that are relevant and engaging for the individual user and thereby more valuable for publishers and third-party advertisers.

Social media

I want to make it as easy as possible for you to share the content of my website via social media, via the social media buttons. Read the privacy policies of these social media companies to know how they handle privacy:

How long I keep your personal data

I do not keep your personal data for longer than is strictly necessary to achieve the purpose(s) for which your data were collected.

Sharing personal data with third parties

Your personal data will only be shared with third parties if this is necessary for the performance of an agreement that we have together and to comply with any legal obligation.

View, modify or delete data

You have the right to know which personal data I process about you and you can request it to be rectified or deleted.

In addition, you have the right to withdraw your consent for data processing or to object to the processing of your personal data by She does it.

You also have the right to data transferability. This means you can submit a request to send the personal data I have from you to you or another organisation mentioned by you.

Do you want to make use of your right to object and / or data transferability or do you have other questions / comments about the data processing, send a specified request to eefke@shedoesitcoaching.com.

After receiving your request, I will respond to you as soon as possible, but in any case, within four weeks.

I would also like to point out that you have the option to make a complaint with the Information Commissioner's Office (ICO).
